## บทที่ 3

# สรุปผลการทดลอง และเสนอแนะ

# 3.1 สรุปผลการทดลอง

จากการทดลองพบว่าได้ผลเป็นที่น่าพอใจเนื่องจากสามารถส่งข้อมูลผ่านระบบ สายไฟได้อย่างมีประสิทธิภาพ โดยมีข้อจำกัดทางด้านอัตราเร็วเนื่องจากมีตัวแปรหลายประการ โดยเฉพาะอย่างยิ่งชืดจำกัดในการแปลงสัญญาณให้มีความผิดพลาดน้อยที่สุด เมื่อใช้ Fregnency to voltage converter และ Voltage-to-freguency converter

ในการทดลองขึ้นนี้ได้ทดสอบเพียงการส่งข้อมูลในลักษณะ Simplex กล่าวคือ
ภาคส่งจะส่งสัญญาณออกไปอย่างเดียวในขณะที่ภาครับจะรับและแปลงสัญญาณอย่างเดียว แต่ใน
งานจริง ๆ แล้ว จำเป็นจะต้องสามารถรับและส่งได้ทั้ง 2 ทาง แม้จะไม่พร้อมกันก็ตาม ซึ่งใน
ทางปฏิบัติแล้วก็น่าจะทำได้ โดยไม่มีบัญหาอะไร แต่เนื่องจากยังไม่ได้ทดสอบในจุดนี้จึงไม่ทราบ
ว่าจะมีผลต่อกันในลักษณะการรบกวนของคลื่นหรือไม่

### 3.2 ชื่อเสนอแนะ

ในงานบางลักษณะที่ไม่จำเป็นที่จะต้องมีการส่งด้วยอัตราเร็วสูง และระบบที่ต้อง การเชื่อมต่อไม่ได้อยู่ห่างกันมากนัก การส่งผ่านข้อมูลทางสายไฟนี้น่าจะเป็นประโยชน์ในแง่ ความสะดวก และความประหยัด แต่ถ้าจะให้เกิดประโยชน์สูงสุด น่าจะสร้างวงจรในลักษณะ half dupex โดยมีวงจรควบคุมสัญญาณต่าง ๆ ด้วยก็น่าจะได้ประโยชนสูงสุด ซึ่งหากสร้าง วงจรรับ/ส่ง และวงจรควบคุมโดยส่งผ่านทาาง RS-232 นี้แบบมาตรฐานแล้ว การเขียน โปรแกรมสั่งงาน อาจไม่จำเป็นเพราะสามารถใช้โปรแกรมมาตรฐาน เช่น Cross talk เพื่อสั่งงานก็ได้ หรือหากต้องการส่งข้อมูลให้ไปพิมพ์ออกทางเครื่องพิมพ์หรือ plotter ก็จะทำ ได้สะดวก เพราะ baud rate นี้สามารถกำหนดได้อยู่แล้ว อีกทั้งอุปกรณ์บางชนิด เช่น printer และ plotter ก็มี buffer อยู่ในตัวทำให้ปัญหาการลันของ buffer ไม่น่าจะมี

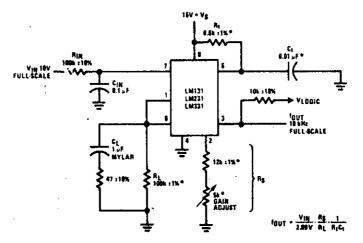

the quick response necessary for 100 kHz voltage-to-frequency conversion. And the output is capable of driving 3 TTL loads, or a high voltage output up to 40V, yet is short-circuit-proof against VCC.

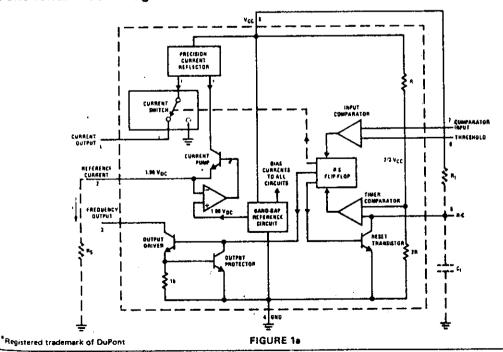

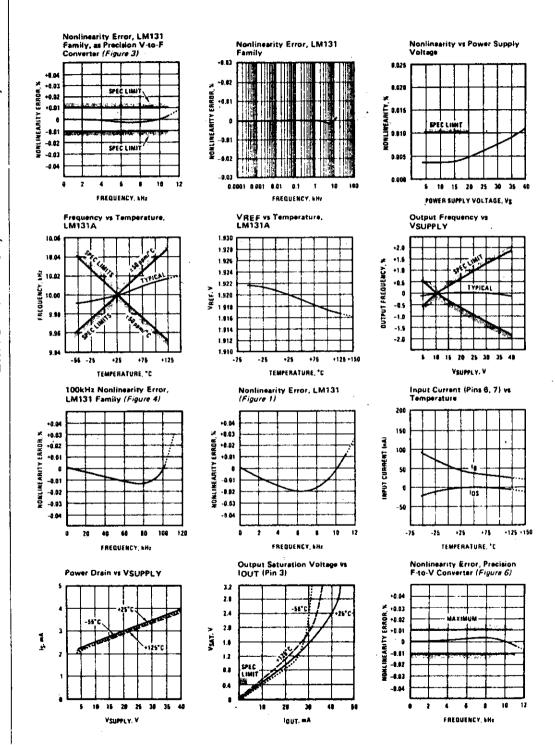

# PRINCIPLES OF OPERATION OF A SIMPLIFIED VOLTAGE-TO-FREQUENCY CONVERTER

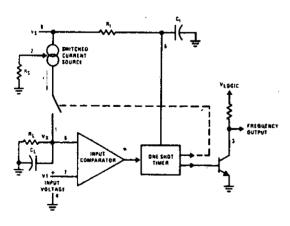


FIGURE 2. Simplified Block Diagram of Stand-Alone Voltage-to-Frequency Converter Showing LM131 and External Components

The LM131 is a monolithic circuit designed for accuracy and versatile operation when applied as a voltage-to-frequency (V-to-F) converter or as a frequency-to-voltage (F-to-V) converter. A simplified block diagram of the LM131 is shown in *Figure 2* and consists of a switched current source, input comparator, and 1-shot timer.

The operation of these blocks is best understood by going through the operating cycle of the basic V-to-F converter. Figure 2, which consists of the simplified block diagram of the LM131 and the various resistors and capacitors connected to it.

The voltage comparator compares a positive input voltage, V1, at pin 7 to the voltage, V<sub>X</sub>, at pin 6. If V1 is greater, the comparator will trigger the 1-shot timer. The output of the timer will trin ON both the frequency output transistor and the switched current source for a period  $t = 1.1 \text{ R}_1\text{C}_1$ . During this period, the current i will flow out of the switched current source and provide a fixed amount of charge,  $Q = 1 \times t$ , into the capacitor, C<sub>L</sub>. This will normally charge V<sub>X</sub> up to a higher level than V1. At the end of the timing period, the current i will turn OFF, and the timer will reset itself.

Now there is no current flowing from pin 1, and the capacitor  $C_L$  will be gradually discharged by  $R_L$  until  $V_{\mathbf{X}}$  falls to the level of V1. Then the comparator will trigger the timer and start another cycle.

The current flowing into CL is exactly fave = i x (1.1 x R<sub>1</sub>C<sub>1</sub>) x f, and the current flowing out of CL is exactly  $V_X/R_L \approx V_{\parallel}N/R_L$ . If  $V_{\parallel}N$  is doubled, the frequency will double to maintain this balance. Even a since y proportional to its input voltage over a wide range of frequencies.

# DETAIL OF OPERATION, FUNCTIONAL BLOCK DIAGRAM (FIGURE 1a)

The block diagram shows a band gap reference which provides a stable 1.9 VDC output. This 1.9 VDC is well regulated over a V<sub>S</sub> range of 3.9V to 40V. It also has a flat, low temperature coefficient, and typically changes less than 1/2% over a 100°C temperature change.

The current pump circuit forces the voltage at pin 2 to be at 1.9V, and causes a current i = 1.90V/R<sub>s</sub> to flow. For R<sub>s</sub> = 14k, i = 135  $\mu$ A. The precision current reflector provides a current equal to i to the current switch. The current switch switches the current to pin 1 or to ground depending on the state of the Rs flip-flop.

The timing function consists of an Rg flip flop, and a timer comparator connected to the external R<sub>1</sub>Ct network. When the input comparator detects a voltage at pin 7 higher than pin 6, it sets the Rg flip flop which turns ON the current switch and the output driver transistor. When the voltage at pin 5 rises to 2/3 VCC, the timer comparator causes the Rg flip flop to reset. The reset transistor is then turned ON and the current switch is turned OFF.

However, if the input comparator still detects pin 7 higher than pin 6 when pin 6 crosses 2/3 VCC, the flip-flop will not be reset, and the current at pin 1 will continue to flow, in its attempt to make the voltage at pin 6 higher than pin 7. This condition will usually apply under start-up conditions or in the case of an overload voltage at signal input. It should be noted that during this sort of overload, the output frequency will be 0; as soon as the signal is restored to the working range, the output frequency will be resumed.

The output driver transistor acts to saturate pin 3 with an ON resistance of about 5002. In case of overvoltage, the output current is actively limited to less than 50 mA.

The voltage at pin 2 is regulated at 1.90 VDC for all values of i between 10  $\mu$ A to 500  $\mu$ A. It can be used as a voltage reference for other components, but care must be taken to ensure that current is not taken from it which could reduce the accuracy of the converter.

### PRINCIPLES OF OPERATION OF BASIC VOLTAGE-TO-FREQUENCY CONVERTER (FIGURE 1)

The simple stand-alone V-to-F converter shown in Figure 1 includes all the basic circuitry of Figure 2 plus a few components for improved performance.

A resistor,  $R_{1N} = 100~k\Omega$  ±10%, has been added in the path to pin 7, so that the bias current at pin 7 (=80 nA typical) will cancel the effect of the bias current at pin 6 and help provide minimum frequency offset.

The resistance  $R_s$  at pin 2 is made up of a 12  $k\Omega$  fixed resistor plus a 5  $k\Omega$  (cermet, preferably) gain adjust rheostat. The function of this adjustment is to trim out the gain tolerance of the LM131, and the tolerance of  $R_t$ ,  $R_L$  and  $C_t$ . For best results, all the components

should be stable low-temperature-coefficient components, such as metal-film resistors. The capacitor should have low dielectric absorption; depending on the temperature characteristics desired, NPO ceramic, polystyrene, Teflon\* or polypropylene are best suited.

A capacitor is added from pin 7 to ground to act as a filter for V<sub>IN</sub>. A value of 0.01  $\mu$ F to 0.1  $\mu$ F will be adequate in most cases; however, in cases where better filtering is required, a 1  $\mu$ F capacitor can be used. When the RC time constants are matched at pin 6 and pin 7, a voltage step at V<sub>IN</sub> will cause a step change in fOUT. If C<sub>IN</sub> is much less than C<sub>L</sub>, a step at V<sub>IN</sub> may cause fOUT to stop momentarily.

A 47 $\Omega$  resistor, in series with the 1  $\mu$ F CL, is added to give hysteresis effect which helps the input comparator provide the excellent linearity (0.03% typical).

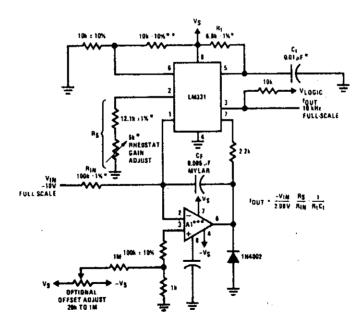
### DETAIL OF OPERATION OF PRECISION V-TO-F CONVERTER (FIGURE 3)

In this circuit, integration is performed by using a conventional operational amplifier and feedback capacitor, CF. When the integrator's output crosses the nominal threshold level at pin 6 of the LM131, the timing cycle is

initiated. The average current fed into the op amp's summing point (pin 2) is i x (1.1 R<sub>2</sub>C<sub>1</sub>) x f which is perfectly balanced with -VIN/RIN. In this circuit, the voltage offset of the LM131 input comparator does not affect the offset or accuracy of the V-to-F converter as it does in the stand-alone V-to-F converter; nor does the LM131 bias current or offset current. Instead, the offset voltage and offset current of the operational amplifier are the only limits on how small the signal can be accurately converted. Since op amps with voltage offset well below 1 mV and offset currents well below 2 nA are available at low cost, this circuit is recommended for best accuracy for small signals. This circuit also responds immediately to any change of input signal (which a stand-alone circuit does not) so that the output frequency will be an accurate representation of VIN, as quickly as 2 output pulses' spacing can be measured.

In the precision mode, excellent linearity is obtained because the current source (pin 1) is always at ground potential and that voltage does not vary with VIN or fOUT. (In the stand-alone V-to-F converter, a major cause of non-linearity is the output impedance at pin 1 which causes i to change as a function of VIN).

The circuit of Figure 4 operates in the same way as Figure 3, but with the necessary changes for high speed operation.

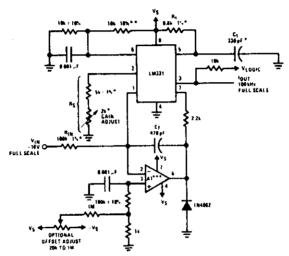
DETAILS OF OPERATION, FREQUENCY-TO-VOLTAGE CONVERTERS (FIGURES 5 AND 6)

In these applications, a pulse input at  $f_{\parallel N}$  is differentiated by a C-R network and the negative-going edge at pin 6 causes the input comparator to trigger the timer circuit. Just as with a V-to-F converter, the average current flowing out of pin 1 is fAVERAGE = i × (1.1 R<sub>1</sub>C<sub>1</sub>) × f.

in the simple circuit of *Figure 5*, this current is filtered in the network  $R_L = 100~k\Omega$  and 1  $\mu$ F. The ripple will be less than 10 mV peak, but the response will be slow,

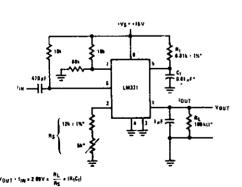
with a 0.1 second time constant, and settling of 0.7 second to 0.1% accuracy.

In the precision circuit, an operational amplifier provides a buffered output and also acts as a 2-pole filter. The ripple will be less than 5 mV peak for all frequencies above 1 kHz, and the response time will be much quicker than in Figure 5. However, for input frequencies below 200 Hz, this circuit will have worse ripple than Figure 5. The engineering of the filter time-constants to get adequate response and small enough ripple simply requires a study of the compromises to be made. Inherently, V-to-F converter response can be fast, but F-to-V response can not.

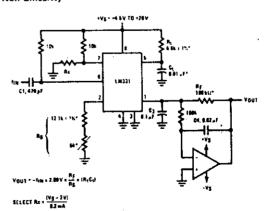

FIGURE 4. Precision Voltage-to-Frequency Converter, 100 kHz Full-Scale, ±0.03% Non-Linearity



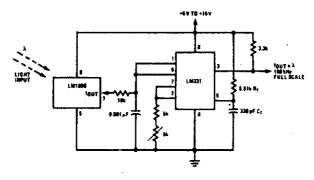

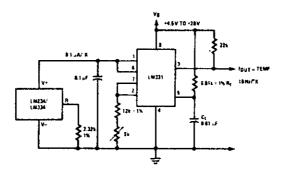

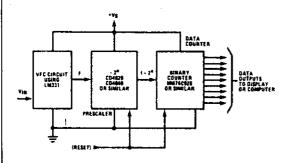

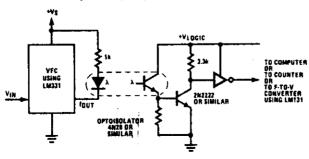
Remote Voltage-to-Frequency Converter with 2-Wire Transmitter and Receiver



Voltage-to-Frequency Converter with Square-Wave Output Using ÷2 Flip-Flop

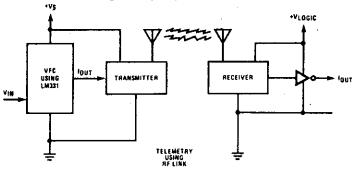

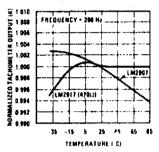




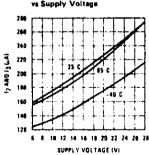




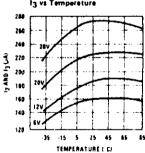
Normalized Tachometer Output vs Temperature



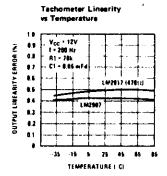
Techometer Currents I<sub>2</sub> and I<sub>3</sub> vs Supply Voltage

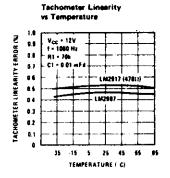


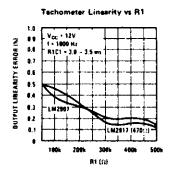
Techometer Currents (2 and 13 vs Temperature

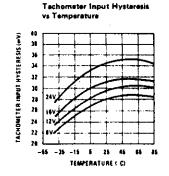


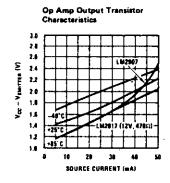

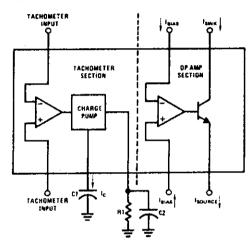
The op amp/comparator is fully compatible with the tachometer and has a floating transistor as its output. This feature allows either a ground or supply referred load of up to 50 mA. The collector may be taken above  $V_{CC}$  up to a maximum  $V_{CE}$  of 28V.

The two basic configurations offered include an 8-pin device with a ground referenced tachometer input and an internal connection between the tachometer output and the op amp non-inverting input. This version is well suited for single speed or frequency switching or fully buffered frequency to voltage conversion applications.

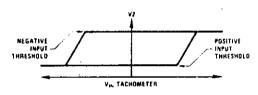
The more versatile configurations provide differential tachometer input and uncommitted op amp inputs. With this version the tachometer input may be floated and the op amp becomes suitable for active filter conditioning of the tachometer output.

Both of these configurations are available with an active shunt regulator connected across the power leads. The regulator clamps the supply such that stable frequency to voltage and frequency to current operations are possible with any supply voltage and a suitable resistor.

The LM2907 series of tachometer circuits is designed for minimum external part count applications and maximum versatility. In order to fully exploit its features and advantages let's examine its theory of operation. The first stage of operation is a differential amplifier driving a positive feedback flip-flop circuit. The input threshold voltage is the amount of differential input voltage at which the output of this stage changes state. Two options (LM2907-8, LM2917-8) have one input internally grounded so that an input signal must swing above and below ground and exceed the input thresholds to produce an output. This is offered specifically for magnetic variable refuctance pickups which typically provide a single-ended ac output. This single input is also fully protected against voltage swings to ±28V, which are easily attained with these types of pickups.

The differential input options (LM2907, LM2917) give the user the option of setting his own input switching level and still have the hysteresis around that level for excellent noise rejection in any application. Of course in order to allow the inputs to attain commonmode voltages above ground, input protection is removed

and neither input should be taken outside the limits of the supply voltage being used. It is very important that an input not go below ground without some resistance in its lead to limit the current that will then flow in the epi-substrate diode.

Following the input stage is the charge pump where the input frequency is converted to a dc voltage. To do this requires one timing capacitor, one output resistor, and an integrating or filter capacitor. When the input stage changes state (due to a suitable zero crossing or differential voltage on the input) the timing capacitor is either charged or discharged linearily between two voltages whose difference is  $V_{\rm CC}/2$ . Then in one half cycle of the input frequency or a time equal to  $1/2~f_{\rm IN}$  the change in charge on the timing capacitor is equal to  $V_{\rm CC}/2~x$  C1. The average amount of current pumped into or out of the capacitor then is:

$$\frac{\Delta O}{T} = i_{c(AVG)} = C1 \times \frac{V_{CC}}{2} \times (2f_{IN}) = V_{CC} \times f_{IN} \times C1$$

The output circuit mirrors this current very accurately into the load resistor R1, connected to ground, such that if the pulses of current are integrated with a filter

capacitor, then,  $V_{\text{p}} = i_{\text{c}} \times R1$ , and the total conversion equation becomes:

Vo TVCC x fin x C1 x R1 x K

Where K is the gain constant-typically 1.0.

The size of C2 is dependent only on the amount of apple voltage allowable and the required response time.

### CHOOSING R1 AND C1

There are some limitations on the choice of R1 and C1 which should be considered for optimum performance. The timing capacitor also provides internal compensation for the charge pump and should be kept larger than 100 pF for very accurate operation. Smaller values can cause an error current on R1, especially at low temperatures. Several considerations must be met when choosing R1. The output current at pin 3 is internally fixed and therefore V<sub>o</sub>/R1 must be less than or equal to this value. If R1 is too large, it can become a significant fraction of the output impedance at pin 3 which degrades linearity. Also output ripple voltage must be considered and the cize of C2 is affected by R1. An expression that describes the ripple content on pin 3 for a single R1C2 combination is.

$$V_{RIPPLE} = \frac{V_{CC}}{2} \times \frac{C1}{C2} \times \left(1 - \frac{V_{CC} \times f_{IN} \times C1}{I_2}\right) pk - pk$$

It appears R1 can be chosen independent of ripple,

however response time, or the time it takes  $V_{OUT}$  to stabilize at a new voltage increases as the size of C2 increases so a compromise between ripple, response time, and linearity must be chosen carefully.

As a final consideration, the maximum attainable input frequency is determined by  $V_{CC}$ , C1 and  $I_2$ :

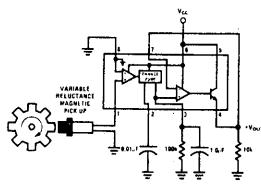

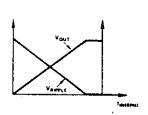
### **USING ZENER REGULATED OPTIONS (LM2917)**

For those applications where an output voltage or current must be obtained independent of supply voltage variations, the LM2917 is offered. The most important consideration in choosing a dropping resistor from the unregulated supply to the device is that the tachometer and op amp circuitry alone require about 3 mA at the voltage level provided by the zener. At low supply voltages there must be some current flowing in the resistor above the 3 mA circuit current to operate the regulator. As an example, if the raw supply varies from 9 to 16V, a resistance of  $470\Omega$  will minimize the zener voltage variation to 160 mV. If the resistance goes under 40032 or over  $600\Omega$  the zener variation quickly rises above 200 mV for the same input variation.

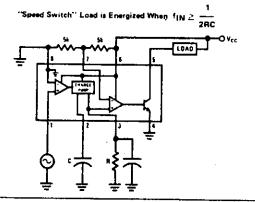

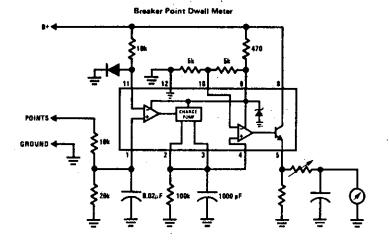




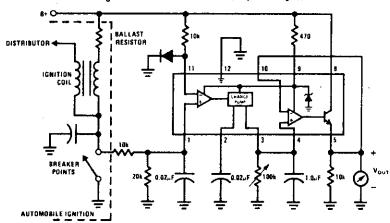
Zener Regulated Frequency to Voltage Converter



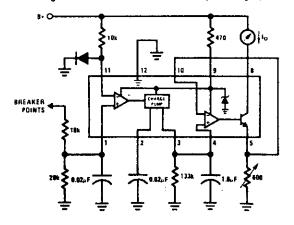




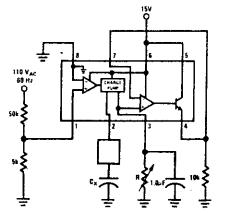

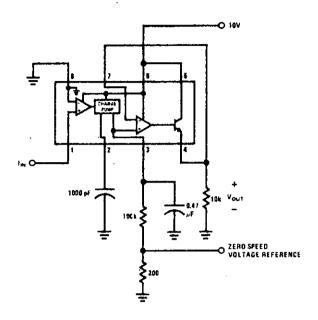


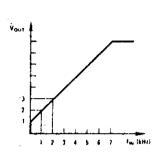




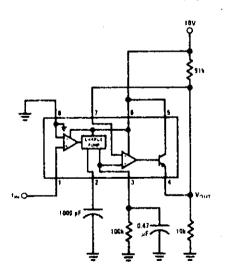


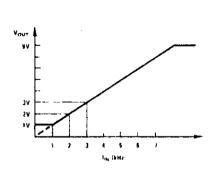
Changing the Output Voltage for an Input Frequency of Zero

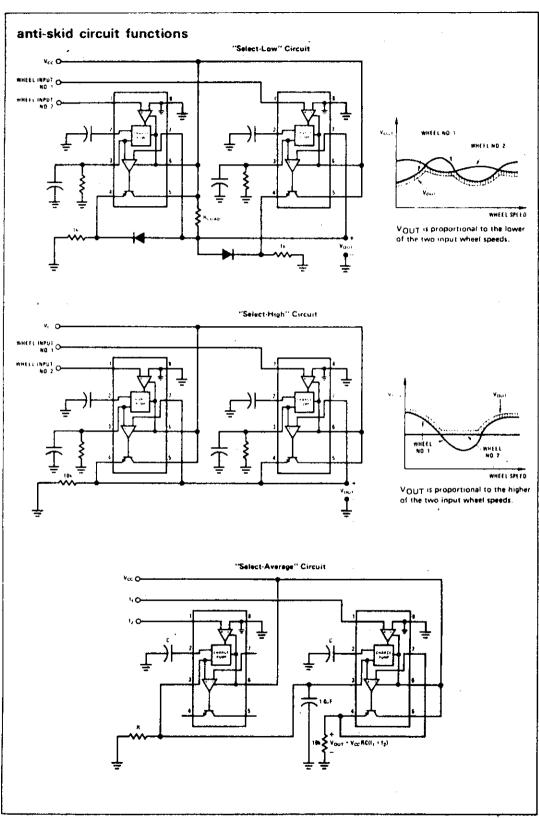




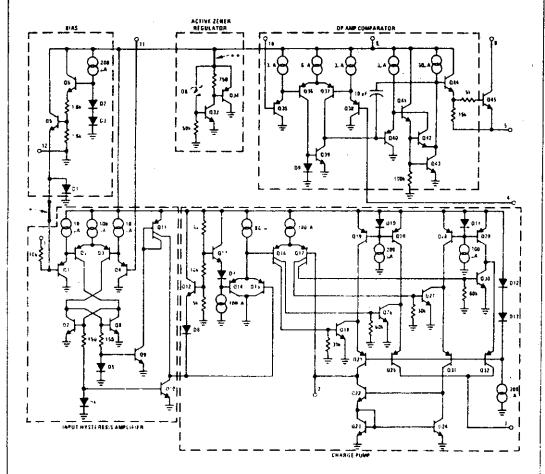
# Changing Tachomater Gain Curve or Clamping the Minimum Output Voltage
